PRIVACY STATEMENT

The Catholic Diocese of Hamilton ("CDOH") is committed to protecting your privacy, as explained in this privacy statement. This statement explains how we may collect, store, use, and disclose any personal information that we collect when you use this website. Your continued use of this website provides your consent to us collecting, storing, using, and disclosing your personal information in the manner set out below.

This statement applies to all the personal information that CDOH collects from you or that you provide on this website (whether permanent or temporary). This statement will not apply to independent websites linked to our site and over which we have no control.

COLLECTION

CDOH may collect personal information from you in several ways, including but not limited to when you visit the site, register for an event, subscribe to a newsletter, respond to a survey, fill out a form, and in connection with other activities, features or resources CDOH makes available on this website. We may collect information including, but not limited to, your name, email address, phone number, postal address, credit card details, and IP address. The extent of personal information collected from you may vary depending on the circumstances, such as the nature of the transaction, registration, or the desired form of communication.

We will collect your personal information only if you submit this information to us. You may decide not to provide your personal information to us. However, if you do not provide some information, it may prevent you from participating in certain website-related activities and services.

When you visit this website, we may collect non-personal information from you. Non-personal information may include the search terms you used, the pages you accessed on our site and the links you clicked on, the date and time you visited the website, the referring site (if any) through which you clicked to our site, your operating system, the type of web browser you use, and other matters such as screen resolution and the language setting of your browser.

CDOH collects all of this information for administrative, financial and analytical purposes.

USE AND DISCLOSURE

CDOH uses the information provided by you to communicate with you. We may also use your information for administration, survey, promotional, marketing, and accounting purposes, or other purposes required by law or regulatory authority. If you decide to be part of the newsletter subscription list of CDOH, you will receive communications that may include news, updates, event information and survey information. If you wish to unsubscribe from the mailing list, you may follow the instructions in the relevant email communication.

CDOH will not disclose your personal information to third parties except where it is necessary for organisational purposes, by law, or by a regulatory authority. We may share generic aggregated demographic information not linked to any personal information regarding you or users of our site with business partners or trusted affiliates for the purposes outlined above. We may also use third-party service providers to assist us in administering events or activities, such as registrations and sending out newsletters or surveys. CDOH may share your information with these third parties for those limited administrative purposes.

SECURITY

CDOH uses a range of security mechanisms and procedures to protect the information it holds about users of this website. The financial information collected from you when CDOH processes your online credit card payment is collected on a secure server that uses the latest encryption technology. This information is strictly confidential, and the only people who have access to this information are the people processing your payment, being Stripe. Please refer to their privacy policy. Our e-commerce sites use Secure Sockets Layer (SSL) technology.

Personal information that is no longer required will be destroyed per relevant legislation- and the Diocesan Records Retention and Disposal Schedule.

A NOTE ABOUT WEBSITE COOKIES

CDOH may use cookies to enhance your experience when using our website. A cookie is a small portion of data, which often includes an anonymous unique identifier, sent from a website and stored in your web browser while browsing a website. Cookies are stored on your computer's hard drive. When the user browses the same website in the future, the website can retrieve cookie data to notify them of the user's previous activity. However, to protect your privacy, your browser permits a website to access only those cookies it sent to you, not the cookies sent to you by other websites. Some cookies are essential for websites to operate.
